### Case Study

The White House Dental Practice in Southall, London, recently overhauled its decontamination processes to achieve the high standards required by HTM 01-05.

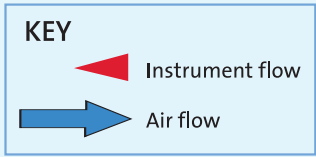
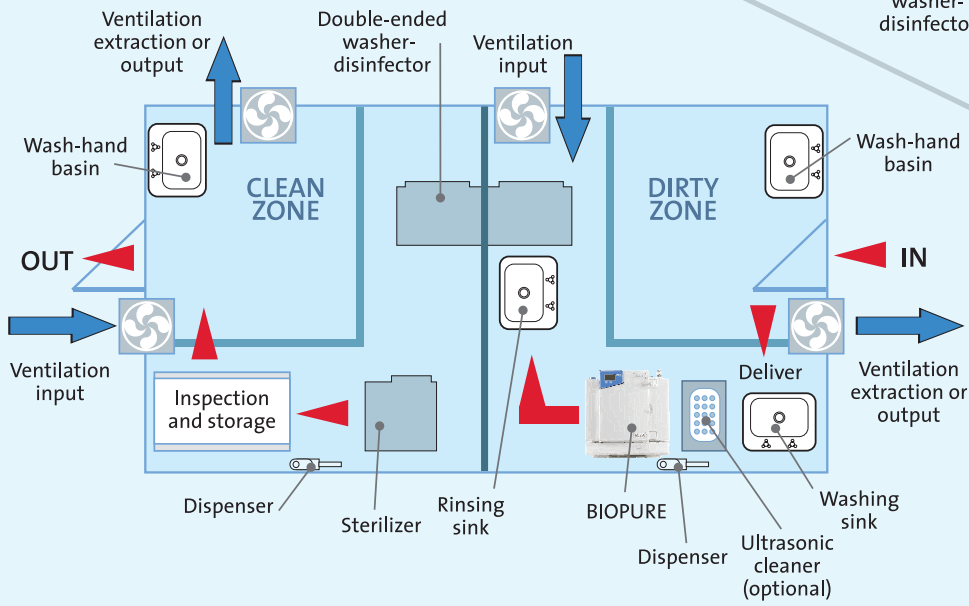
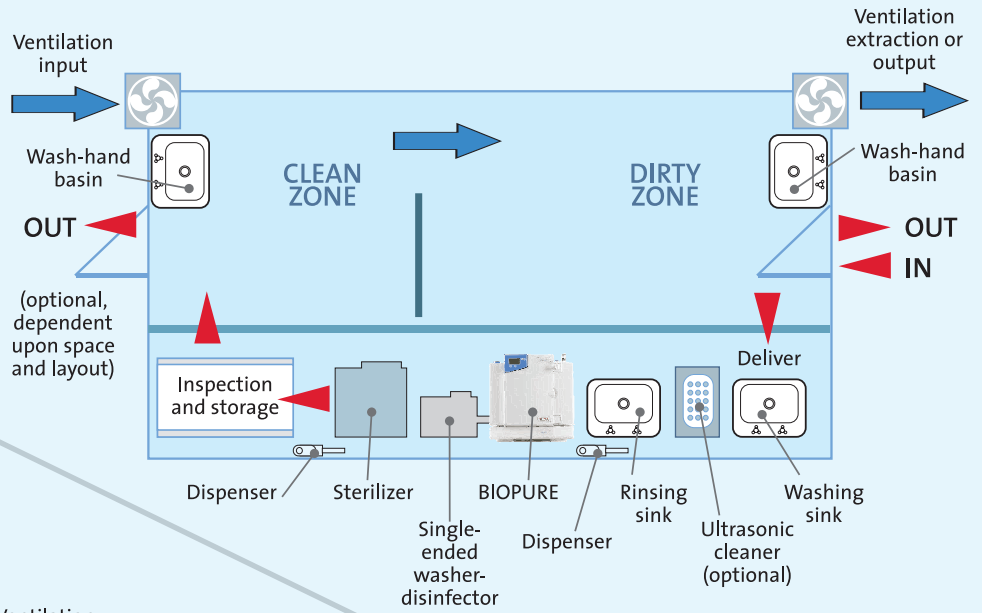
